The exam will be conducted online, unlike other online exam; it can be accessed from any PC, laptops or through mobile phone having internet connection. The biggest benefit of such system is that, it will reduce the cost of examination significantly, besides it will also save applicant's travelling time who have to travel long ways to appear for exam by spending money on travel and food and time spent on such journeys will also be saved which could be utilized in various productive ways. Beside all these benefits online exam system is also capable of reducing the time in processing the result which will enable us to deliver the result and scholarships faster i.e. in just 2 days result will be declared and within next 2-3 days scholarship will be disbursed, this way the organization would be able to fulfill its commitment of helping the meritorious population from all section of society expeditiously with ZERO formalities and NEGLIBLE Procedures.

### **SCHEME OF EXAMINATION**

The selection process for the scholarship will comprise of an ONLINE Test of MCQs. The structure of the Examination is as follows:

**PENALTY FOR WRONG ANSWERS** - For each wrong answer one third or  $1/3^{\text{rd}}$  of the marks assigned to that question will be deducted as penalty. If a question is left blank, i.e. no answer is marked by the candidate; there will be no penalty for that question.

## **NOTE**

Test will be conducted on mobile application and/or computer application (for windows only). Link to download mobile application/computer application will be provided on the website <http://www.medhavionline.org> well in advance before the date of commencement of examination, any updates regarding exam will be intimated through email only, if due to any technical reasons, out of the purview of the organization, candidate/s do not receive email they are advised to visit website regularly for updates.

Candidates are also advised to attempt 'MOCK TEST', well in advance, available at the website to become familiar with the format of examination.

**The exam will consist of 4 (four) sections, each section will be assigned time limit; the candidate will have to complete the given section within given time. To avert any chance of discrepancy, there shall be no back option, which means candidate need to attempt the question appearing on the screen or press next button leaving the question unanswered. Candidate must make it sure that they attempt all the questions within given time limit for each section as no extra time will be given.**

## **FEE FOR TEST**

- a) A registration fee of Rs.300 (Three hundred only) for all category (General/OBC/SC/ST) applicants need to be paid for the online test; based on the online test merit will be prepared.
- b) The registration fee of Rs.300 (Three hundred only) is *REFUNDABLE* to all those candidates who score more than a passing score of 35% and do not come under any merit list.**
- c) Applications without the prescribed payment would not be considered and summarily rejected. No representation against such rejection would be entertained.
- d) PRESCRIBED FEE IS FOR THE ONLINE TEST ONLY; MERELY PAYMENT OF FEE DOES NOT ENTITLE AN APPLICANT FOR THE SCHOLARSHIP. PAYMENT ONCE PAID SHALL NOT BE REFUNDED UNDER ANY CIRCUMSTANCE, EXCEPT AS PER THE CONDITION MENTIONED UNDER POINT (b) ABOVE, NOR CAN THE FEE BE HELD IN RESERVE FOR ANY OTHER EXAMINATION OR SELECTION.**

**SCHOLARSHIP :**

689 Candidate will be awarded Rs.6000/- (Type A) as scholarship for 2 consecutive months; 523 Candidates will be awarded Rs.3000/- (Type B) as scholarship for 2 consecutive months; 235 candidate will be awarded with Rs.1500/- (Type C) as scholarship for 2 consecutive months; and candidates who scores a minimum passing marks 35% or above and do not come under any merit list will be given Rs.300 (one time only) as refund of registration fee.

Number of scholarship is subject to merit list & number of application received which may be increased or decreased, decision, regarding increasing of scholarship or decreasing of scholarship, of organization will be final.

**Monthly scholarship will be paid in two consecutive months. Scholarship distribution and refund of registration fee will start from 31.07.2019**

Result will be prepared on the basis of merit of the candidates. Merit list in any case will not be less than 35% of the maximum marks, no candidate will be considered for merit securing less than 35% marks.

**PAYMENT OF SCHOLARSHIP TO SUCCESSFUL CANDIDATES**

Payment of scholarship to candidates will be done through transfer in the **bank account** or **PayTM** wallet in the name of the applicant. All applicants are requested to have an active bank account and PayTM wallet account.

**ELIGIBILITY**

Candidates are requested to apply only Online against this advertisement on the website <http://www.medhavionline.org> and NOT write to the Organization for Application forms. They are also requested to go through carefully the details and instructions published on the website <http://www.medhavionline.org>

**AGE LIMIT:**

Minimum age limit is 16 years and maximum 40 years for all candidates.

**CITIZENSHIP:**

A Candidate must be either:

- (a) a citizen of India, or
- (b) a subject of Nepal, or
- (c) a subject of Bhutan, or
- (d) a Tibetan refugee who came over to India before 1st January, 1962 with the intention of permanently settling in India, or
- (e) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka or East African countries of Kenya, Uganda, the United Republic of Tanzania(formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India. Provided that a candidate

belonging to categories (b), (c), (d) and (e) above shall be a person in whose favour a certificate of eligibility has been issued by the Government of India.

#### **MINIMUM ESSENTIAL QUALIFICATIONS:**

A candidate must have passed matriculation (10<sup>th</sup>) or equivalent examination from a board recognized by the central government or state government.

Matriculation /10<sup>th</sup> is only minimum qualification which means candidates who have passed intermediate/12<sup>th</sup>, Graduation, Post-Graduation or any other degree/diploma higher than matriculation/10<sup>th</sup> can apply for this scholarship.

#### **HOW TO APPLY:**

**Note:** CANDIDATES ARE ADVISED TO FILL THEIR CORRECT AND ACTIVE E-MAIL ADDRESSES IN THE ONLINE APPLICATION AS ALL CORRESPONDENCE WILL BE MADE THROUGH E-MAIL ONLY. FURTHER SCHEDULE AND REQUIREMENTS (if any) WITH REGARD TO COPIES OF CERTIFICATES TO BE SUBMITTED IN RESPECT OF CLAIMS MADE IN THE ONLINE APPLICATION WILL BE E-MAILED IN DUE COURSE TO THE CANDIDATES IN THEIR REGISTERED E-MAIL ID OR WILL BE POSTED ON THE WEBSITE.

1. Candidates must apply online through the website <http://www.medhavionline.org>. Applications received through any other mode would not be accepted and summarily rejected.
2. Filling of ***Personal Details***.
3. Fee submission.
4. Submit the form after fee deposit.
5. A confirmation mail consisting registration ID will be sent to the E-mail of the candidate.
6. After submitting the Online Application (OA), the candidates are required to take snap shot of the finally submitted Online Application (OA).
7. Candidates are not required to submit to the Organization either by post or by hand the printouts of their online applications or any other document.
8. The candidates are advised to submit the Online Application well in advance without waiting for the closing date.

**NOTE**

To ensure that only meritorious candidates get the scholarship a criteria has been fixed by the organization which is as follows; Three different types of scholarship will be disbursed to candidates who score more than prescribed percentage of marks i.e. *Type A* scholarship will be awarded to those candidates who score sixty percent or above marks; *Type B* scholarship only to those candidates who score more than or equal to fifty percent and below sixty percent; *Type C* scholarship will be given to those candidates who score more than or equal to Forty percent and less than fifty percent marks and finally candidates who scores a minimum passing marks 35% or above and do not come under any merit list will be given Rs.300 (one time only) as refund of registration fee.

**DATE, TIME & VENUE OF EXAMINATION**

- I. Tentative date for examination is 21 July 2019 (Sunday). Time of examination will be intimated via E-mail.
- II. Center of examination is to be decided by the candidate. This is an **ONLINE EXAMINATION** and can be accessed from any *Personal Computer, laptops* or mobile phone\* having internet connection at home or cyber café. Therefore applicants are free to choose their location for exam as per their convenience.

**NOTE:**

IN THE **EVENT OF TIE**, AUTHORITY WILL ADOPT SHORT LISTING CRITERIA TO SELECT THE CANDIDATES FOR SCHOLARSHIP TO A REASONABLE NUMBER BY ANY OR MORE OF THE FOLLOWING METHODS:

- A. On the basis of number obtained in General studies section.
- B. On the basis of number obtained in English section.
- C. On the basis of number obtained in Quantitative Aptitude section.
- D. On the basis of number obtained in Reasoning section.
- E. On the basis of time taken by the candidates
- F. On the basis of marks obtained in the matriculation/10<sup>th</sup>.
- G. Candidate of higher age will be preferred.
- H. Lucky draw (if required)

Comprehension Reasoning, Venn Diagrams, Number Series, Coding and decoding, Problem Solving Techniques, Statement & Conclusion type questions, Arithmetic reasoning, Arithmetical number series, Non-verbal series, Syllogistic reasoning, Seating Arrangements, Blood relations, Ranking, Distance & Direction, Mathematical Inequalities.

### **QUANTITATIVE APTITUDE**

Number Systems, Computation of Whole Numbers, Decimals and Fractions and relationship between Numbers, Fundamental arithmetical operations, Percentages, Ratio and Proportion, Averages, Interest, Profit and Loss, Discount, Mensuration, Time and Distance, Ratio and Time, Time and Work.

### **ENGLISH**

Spotting errors, Fill in the blank Cloze Test, Idioms & Phrases, Synonyms and antonyms, Reconstruction of sentence & passage, one word substitution, Phrase substitution, Jumbled up sentences, Double blanks in a sentence, commonly misspelled words, Comprehension passages, correction of sentences, synthesis of sentences.
